(2) on or between the 19th day of MARCH, 2025 and the 29th day of MAY, 2025, at and within Stephenson County, Illinois, did commit the offense of POSSESSION OF CHILD PORNOGRAPHY (Child Under 13) in violation of 720 ILCS 5/11-20.1(a)(6)(c-5), in that said defendant, with the knowledge of the nature or content thereof, possessed a depiction by computer or other similar visual medium or reproduction, being a computer file named "!!! New !!! 2006 Privado Warrior Luvnlilly 3Yo.avi", of a child whom defendant reasonably should have known to be under the age of 13 years, which did show such child actually or by simulation engaged in an act of sexual penetration or sexual conduct with another person.

(3) on or between the 19th day of MARCH, 2025 and the 29th day of MAY, 2025, at and within Stephenson County, Illinois, did commit the offense of POSSESSION OF CHILD PORNOGRAPHY (Child Under 18) in violation of 720 ILCS 5/11-20.1(a)(6), in that said defendant, with the knowledge of the nature or content thereof, possessed a depiction by computer or other similar visual medium or reproduction, being a computer file named "!!NEW RCW Siting Room 13yo Lennia%%.avi", of a child whom defendant reasonably should have known to be under the age of 18 years, which did show such child actually or by simulation engaged in an act of sexual penetration or sexual conduct with another person.
