
## Primary Narrative By Rachel Bruce

### INITIAL NARRATIVE

On January 23, 2025, I met with [REDACTED] and her mother, [REDACTED] regarding another case (R2404195). During this contact, [REDACTED] and [REDACTED] expressed concern to me regarding possible emergency protective order violations by the suspect in the other case, Jesse Mack Butler.

[REDACTED] reported she felt intimidated and harassed by Jesse Butler, due to continued unnecessary contact with him at her school. [REDACTED] stated Butler had not tried to verbally interact with her, but he appeared to insert himself in locations he knew she would be at. [REDACTED] stated this typically occurred in the parking lot of Stillwater High School and while walking into the school. [REDACTED] made the referenced report in September 2024 and also obtained an emergency

protective order against Butler. The EPO, JDL-24-22, was obtained on 09/26/2024. Butler was served the EPO and appeared in court for a hearing on 01/06/2025. The EPO is still currently in place.

### **CHARGES, ARREST, AND CASE CLOSURE NARRATIVE**

On March 3, 2025, Jesse Mack Butler was charged with attempted rape in the first-degree x 2, rape by instrumentation x 3, sexual battery, forcible oral sodomy, domestic assault and battery by strangulation x 2, and domestic assault and battery (CF-2025-59). These charges were based upon investigation into allegations in R2404195 and R2404196.

In addition to these charges, an emergency protective order was sought by one of the victims, [REDACTED]. The current investigation was based upon allegations that Jesse Butler violated the EPO. Probable cause existed in this case, and I prepared an affidavit for violation of an EPO. I presented the affidavit to Assistant District Attorney Debra Vincent on 02/18/2025.

On August 25, 2025, Jesse Butler's charges were amended to include Violation of a Protective Order in CF-2025-59. Butler plead no contest to all the charges, including Violation of a Protective Order.

This case should be CLEARED BY ARREST and closed.
