COMES NOW, VICTORIA D. NOEL, as Assistant County Attorney of Scott County, State of Iowa, and in the name and by the authority of the State of Iowa, accuses SCOTT A. STOWE of the following crime(s):

COUNT 1:

SEXUAL ABUSE - 2ND DEGREE

(B FELONY)

The said SCOTT A. STOWE on or about the 1st day of October, 2021 through the 31st day of March, 2025, in the County of Scott, and State of Iowa did: commit sexual abuse upon E.U. (DOB 2010), a child, by making contact between his hand and the child’s genitalia in violation of Section 709.3(1)(b) of the Code of Iowa.

COUNT 2:

SEXUAL ABUSE - 2ND DEGREE

(B FELONY)

The said SCOTT A. STOWE on or about the 1st day of October, 2021 through 31st day of March, 2025, in the County of Scott, and State of Iowa did: commit sexual abuse upon E.U.

(DOB 2010), a child, by creating contact between the child's hand and the Defendant's genitalia, in violation of Section 709.3(1)(b) of the Code of Iowa.

COUNT 3:

SEXUAL ABUSE - 2ND DEGREE

(B FELONY)

The said SCOTT A. STOWE on or about the 1st day of October, 2021 through 31st day of March, 2025, in the County of Scott, and State of Iowa did: commit sexual abuse upon E.U. (DOB 2010), a child, by making contact between his mouth and the child's genitalia, in violation of Section 709.3(1)(b) of the Code of Iowa.

COUNT 4:

SEXUAL ABUSE - 2ND DEGREE

(B FELONY)

The said SCOTT A. STOWE on or about the 1st day of October, 2021 through the 31st day of March, 2025, in the County of Scott, and State of Iowa did: commit sexual abuse upon E.U. (DOB 2010), a child, by creating contact between the child's mouth and the Defendant's genitalia, in violation of Section 709.3(1)(b) of the Code of Iowa.

COUNT 5:

SEXUAL ABUSE - 2ND DEGREE

(B FELONY)

The said SCOTT A. STOWE on or about the 1st day of October, 2021 through the 31st day of March, 2025, in the County of Scott, and State of Iowa did: commit sexual abuse upon E.U. (DOB 2010, a child, through penetration of the child's penis into the Defendant's anus, in violation of Section 709.3(1)(b) of the Code of Iowa.

COUNT 6:

SEXUAL ABUSE - 2ND DEGREE

(B FELONY)

The said SCOTT A. STOWE on or about the 1st day of October, 2021 through the 31st day of March, 2025, in the County of Scott, and State of Iowa did: commit sexual abuse upon E.U. (DOB 2010), a child, by use of an artificial sex organ on the child's penis, in violation of Section 709.3(1)(b) of the Code of Iowa.

COUNT 7:

LASCIVIOUS ACTS WITH A CHILD - FONDLE OR TOUCH

(C FELONY)

The said SCOTT A. STOWE on or about the 1st day of October, 2021 through the 31st day of March, 2025, in the County of Scott, and State of Iowa did: fondle or touch the pubes or genitals of E.U. (DOB 2010), a child, for the purpose of arousing or satisfying the sexual desires of either of them in violation of Section 709.8(1)(a) of the Code of Iowa.

COUNT 8:

LASCIVIOUS ACTS WITH A CHILD - PERMIT/CAUSE CHILD TO FONDLE

(C FELONY)

The said SCOTT A. STOWE on or about the 1st day of October, 2021 through the 31st day of March, 2025, in the County of Scott, and State of Iowa did: permit E.U. (DOB 2010), a child, to fondle or touch his or her genitals or pubes for the purpose of arousing or satisfying the sexual desires of either of them in violation of Section 709.8(1)(b) of the Code of Iowa.

COUNT 9:

LASCIVIOUS ACTS WITH A CHILD – SOLICITATION

(D FELONY)

The said SCOTT A. STOWE on or about the 1st day of October, 2021 through the 31st day of March, 2025, in the County of Scott, and State of Iowa did: solicit a child to engage in a sex act for the purpose of arousing or satisfying the sexual desires of either of them in violation of Section 709.8(1)(d) of the Code of Iowa.

COUNT 10:

INDECENT CONTACT WITH A CHILD

(AGGRAVATED MISDEMEANOR)

The said SCOTT A. STOWE on or about the 1st day of October, 2021 through the 31st day of March, 2025, in the County of Scott, and State of Iowa did: fondle or touch the inner thigh, groin, buttock, anus, or breast of E.U. (DOB 2010), a child, for the purpose of arousing or satisfying the sexual desires of either of them in violation of Section 709.12(1)(a) of the Code of Iowa.

COUNT 11:

INDECENT CONTACT WITH A CHILD

(AGGRAVATED MISDEMEANOR)

The said SCOTT A. STOWE on or about the 1st day of October, 2021 through the 31st day of March, 2025, in the County of Scott, and State of Iowa did: touch the clothing covering the immediate area of the inner thigh, groin, buttock, anus, or breast of E.U. (DOB 2010), a child, for the purpose of arousing or satisfying the sexual desires of either of them in violation of Section 709.12(1)(b) of the Code of Iowa.

COUNT 12:

INDECENT CONTACT WITH A CHILD

(AGGRAVATED MISDEMEANOR)

The said SCOTT A. STOWE on or about the 1st day of October, 2021 through the 31st day of March, 2025, in the County of Scott, and State of Iowa did: solicit a child to engage in a lascivious act in violation of Section 709.12(1)(d) of the Code of Iowa.

COUNT 13:

SEXUAL EXPLOITATION BY ADULT PROVIDING TRAINING/INSTRUCTION

(D FELONY)

The said SCOTT A. STOWE on or about the 1st day of October, 2021 through the 31st day of March, 2025, in the County of Scott, and State of Iowa did: show a pattern or practice or scheme to have sexual conduct with a minor for the purpose of arousing or satisfying the sexual desires of the adult providing training or instruction or of the minor by kissing or touching of the

clothed or unclothed inner thigh, breast, groin, buttock, anus, pubes or genitals while being an adult providing training or instruction in violation of Section 709.15(7)(a) of the Code of Iowa.

COUNT 14:

SEXUAL EXPLOITATION BY ADULT PROVIDING TRAINING/INSTRUCTION

(AGGRAVATED MISDEMEANOR)

The said SCOTT A. STOWE on or about the 1st day of October, 2021 through the 31st day of March, 2025, in the County of Scott, and State of Iowa did: have sexual conduct with a minor for the purpose of arousing or satisfying the sexual desires of the adult providing training or instruction or of the minor by kissing or touching of the clothed or unclothed inner thigh, breast, groin, buttock, anus, pubes or genitals while being an adult providing training or instruction in violation of Section 709.15(7)(b) of the Code of Iowa.

COUNT 15:

SEXUAL EXPLOITATION BY ADULT PROVIDING TRAINING/INSTRUCTION

(AGGRAVATED MISDEMEANOR)

The said SCOTT A. STOWE on or about the 1st day of October, 2021 through the 31st day of March, 2025, in the County of Scott, and State of Iowa did: have sexual conduct with a minor for the purpose of arousing or satisfying the sexual desires of the adult providing training or instruction or of the minor by kissing or touching of the clothed or unclothed inner thigh, breast, groin, buttock, anus, pubes or genitals while being an adult providing training or instruction in violation of Section 709.15(7)(b) of the Code of Iowa.

COUNT 16:

DISSEMINATION AND EXHIBITION OF OBSCENE MATERIAL TO MINORS

(SERIOUS MISDEMEANOR)

The said SCOTT A. STOWE on or about the 1st day of October, 2021 through the 31st day of March, 2025, in the County of Scott, and State of Iowa did: knowingly disseminate or exhibit obscene material to E.U. (DOB 2010), a minor, by showing the minor pornography, in violation of Section 728.2(1) of the Code of Iowa.

COUNT 17:

DISSEMINATION AND EXHIBITION OF OBSCENE MATERIAL TO MINORS

(SERIOUS MISDEMEANOR)

The said SCOTT A. STOWE on or about the 1st day of October, 2021 through the 31st day of March, 2025, in the County of Scott, and State of Iowa did: knowingly disseminate or exhibit obscene material to E.U. (DOB 2010), a minor, by showing the minor a picture of the Defendant nude, in violation of Section 728.2(1) of the Code of Iowa.

COUNT 18:

DISSEMINATION AND EXHIBITION OF OBSCENE MATERIAL TO MINORS

(SERIOUS MISDEMEANOR)

The said SCOTT A. STOWE on or about the 1st day of October, 2021 through the 31st day of March, 2025, in the County of Scott, and State of Iowa did: knowingly disseminate or exhibit obscene material to E.U. (DOB 2010), a minor, by showing the minor a picture of a nude adult male, in violation of Section 728.2(1) of the Code of Iowa.
